European Accreditation

Accreditation Statement

»Live educational activities, occurring outside of Canada, recognized by the UEMS-EACCME for ECMEC credits are deemed to be Accredited Group Learning Activities (Section 1) as defined by the Maintenance of Certification Program of The Royal College of Physicians and Surgeons of Canada.«

EACCME credits

Each medical specialist should claim only those hours of credit that he/she actually spent in the educational activity. The EACCME credit system is based on 1 ECMEC per hour with a maximum of 3 ECMECs for half a day and 6 ECMECs for a full-day event.

Logo

The UEMS – EACCME logo is a service mark of the European Union of Medical Specialists – European Accreditation Council for CME. This service mark may be used publicly only with the permission of the UEMS – EACCME. The logo may only be used in conjunction with, and in proximity to, the EACCME accreditation statement.
